Addressing the use of individual resilience as a form of gaslighting in healthcare organisations

While resilience is often promoted by healthcare organisations as a personal coping strategy, this approach risks overlooking systemic issues and structural inequalities that significantly affect staff wellbeing. This article critically explores the growing emphasis on resilience as a strategy for managing the stresses and demands experienced by nurses. It also examines how an overreliance on resilience can shift responsibility from organisations to individuals.

The use of an escape room-based learning strategy to enhance pharmacology knowledge among nursing students

Nursing students may experience difficulties in understanding complex pharmacological concepts and applying this knowledge in clinical decision-making processes during their pharmacology education. Traditional teaching methods do not always support active participation and lasting knowledge acquisition in the learning process. Florence Nightingale laid the foundation stone of nursing accountability with this famous quote: 'I attribute my success to this: I never gave or took any excuse.' For Nightingale, excuses are not taken as a justification of actions discounting any responsibility, but instead she celebrates the capacity to take responsibility for any consequence that occurs from those actions. Fast-forward a century or so, and accountability and responsibility are still central tenets of nursing values.

CPD focus: a critical examination of five common wound care myths

Despite a growing body of evidence on wound healing and wound infection management, misconceptions about wound care remain entrenched in nursing practice. These misconceptions can result in suboptimal patient outcomes. This article critically examines five common wound care myths and provides guidance for nurses to support them to provide evidence-based wound care aligned with principles of best practice.

Designing accessible and usable clinical policies to enhance patient safety

Clinical policies in healthcare, such as guidelines, protocols, procedures and care pathways, are essential to guide decision-making and standardise practice. Investigations into patient safety incidents have often found that clinical policies were not followed, attributing this to inadequately designed and inaccessible policies that are detached from the realities of clinical practice. This article discusses clinical policy design, explores the effects of inadequately designed policies and considers why policies may fail.

Opioids and long-term pain management: nursing considerations
