[Nursing shortages and patient outcomes](#)

This paper examines the effect of nurse shortages on healthcare production. We examine what effect the absence of nursing staff has on inpatient mortality and other outcomes associated with nursing care. The findings show that for the average ward, the absence of a nurse with university degree-equivalent level training increases the odds of a patient death by approximately 10%.

Quality of life in patients with monoclonal B-cell lymphocytosis or chronic lymphocytic leukaemia managed by active monitoring

Several aspects of quality of life may be particularly affected among many patients with MBL and CLL managed by active monitoring. Therefore, cancer nurses and other healthcare professionals should aim to identify and address the needs of patients with MBL and CLL to ensure they receive holistic care.

Assessing frailty in older adults with cancer to optimise care provision and outcomes

The presence of frailty in older adults with cancer significantly affects treatment tolerance, recovery from treatment, complications and overall survival. This article discusses the importance of early identification of frailty in older adults followed by referral for a comprehensive geriatric assessment (CGA). The article also describes how CGA supports a multidisciplinary and personalised care approach to identifying and managing an individual's needs to optimise their ability to manage their cancer and cancer treatments.

Clinical management of acute post-operative bladder spasm in children and young people

How mental health nurses can lead change away from restrictive practice

However, a growing body of evidence details variations in practice surrounding IFR due to differences in clinical guidelines. Role of enhanced therapeutic observations and care in maintaining the well-being and safety of mental health inpatients

Enhanced therapeutic observations and care (ETOC) enable mental health professionals to observe patients receiving inpatient care. However, while enhanced observations have



an important role in risk assessment and management, patients may experience them as isolating, restrictive, lacking privacy and distressing. This article promotes best practice by considering the legal, ethical and professional duties of mental health nurses carrying out ETOC so that they can perform this clinical skill in a way that supports patient safety.

Supporting people with hoarding behaviour: a health promotion perspective

Hoarding disorder is a complex mental health condition that is increasingly recognised as both a health concern for the individual and a wider public health issue. This article examines hoarding behaviour through a health promotion lens, with a focus on the role of the nurse. The author also provides guidance for nurses on starting conversations about hoarding behaviour with individuals, assessing the severity of the issue and initiating and supporting behaviour change.

Should I specialise early or gain ward experience first?

Experienced nurses weigh the advantages of taking a ward role or a specialist path as a newly registered nurse. Ward work is central to many nurses' early careers and the experience gained often helps inform their future choices.
