An exploration of barriers and enablers to the expansion of healthcare degree apprenticeships

University Alliance & The University of Derby, February 2025

A new report has identified several significant barriers to the expansion of degree apprenticeship routes to deliver the workforce targets as set out in the NHS Long-Term Workforce Plan. The report highlights financial constraints and disincentives, issues with capacity and support, as well as coordination challenges between employers and education providers.

NICE Update: Tobacco: preventing uptake, promoting quitting and treating dependence NICE, February 2025

Updated guidance for supporting patients to stop smoking, including a new recommendation on cytisinicline and an update to recommendations on stop-smoking interventions and pharmacological support during pregnancy.

Factors associated with burnout among internationally educated nurses: A scoping review **International Nursing Review, Volume 72, Issue 1**

The increasing nursing shortage in the healthcare industry has become a concern in many countries. Recruiting certified nurses from outside a country is one strategy to address this shortage. While the hiring of internationally educated nurses (IENs) fills the labor gap, a supportive work environment is necessary to retain IENs in the field.

Promoting a healthy work environment: Increasing staff confidence to address incivility Nursing Management, Volume 56, Issue 2

For years, incivility has been an issue in the nursing profession and is a leading cause of nurses' intent to leave the profession.4 Incivility negatively impacts patient outcomes, patient satisfaction, nurse satisfaction, and turnover. Evidence supported an educational intervention to increase knowledge of behaviors associated with incivility and mechanisms to address those behaviors.

Understanding burnout in nurses: identification and coping strategies British Journal of Nursing, Volume 34, Issue 4

Burnout, a psychological syndrome caused by prolonged exposure to chronic workplace stressors, is a prevalent issue in nursing, characterised by emotional exhaustion,







depersonalisation and a diminished sense of accomplishment. This article explores the widespread impact of burnout in nursing, identifying its key indicators and consequences for both nurses and patient care. It evaluates evidence-based management strategies aimed at mitigating burnout and improving outcomes.

A local anaesthetic infusion is a prescribed method of continuous analgesia to manage post-operative pain as part of a multimodal approach, which may also include an analgesic. During the infusion, local anaesthetic is infused into the tissues surrounding the surgical incision or wound via a multi-lumen indwelling wound catheter.

Community nurses face challenges while caring for patients with complex conditions, posthospital recovery needs, or palliative care requirements, which increases their exposure to





bloodborne pathogens. Preventive measures, such as proper use of personal protective equipment, prompt reporting and post-exposure prophylaxis are essential to minimise the risk of transmission.

Respiratory assessment for registered nurses using a systematic approach: the RIPPAS framework

Systematic assessment of the respiratory system is an important skill for both the identification of pertinent patient symptoms and for the evaluation of care provided. Although this assessment has historically been performed by advanced clinical practitioners in the community setting, since 2019, the Nursing and Midwifery Council made it a required skill for its new registrants and all nursing students in the UK.

The role of nutrition in wound healing and implications for nursing practice
