<u>Meningitis (bacterial) and meningococcal disease: recognition, diagnosis and management—summary of updated NICE guidance</u>

#### BMJ, 387, 27<sup>th</sup> November 2024

In this article, we summarise selected recommendations related to early recognition of these conditions, timing of investigations, initiating antibiotic therapy, and follow-up.

#### On the Frontline of the UK's Corridor Care Crisis

Patients dying in corridors, lack of equipment and unsafe practices are the findings of a new RCN report documenting the experiences of more than 5,000 NHS nursing staff. This report includes the raw, unedited and often heart-breaking responses of nursing staff working across the UK.

Practice learning in nursing and midwifery education: an independent rapid review

Students training for nursing, midwifery and nursing associate roles are required to complete hands-on 'practice learning' hours as a part of their qualification. This report examines the current regulations and standards for practice learning in the UK. It explores the factors that contribute to a positive learning environment, including practice supervision and assessment.

Integrating trauma-informed care in nursing practice and education: A hybrid systematic narrative review

#### Nurse Education in Practice, Volume 82

Nurses generally showed positive attitudes toward trauma informed care; however, significant knowledge gaps and implementation barriers remained. Addressing these challenges by incorporating TIC into nursing education could enhance nursing competencies.







Nursing Interventions to Prevent Posttraumatic Stress Disorders in People in Intensive Care: A Scoping Review

#### Dimensions of Critical Care Nursing, Vol 44 Part 1 pp. 36-43

Identifying nursing interventions that prevent posttraumatic stress in people hospitalized in intensive care allows nurses to develop care plans that include these interventions in the context of intensive care, with a view to improving the quality of nursing care provided.

Nursing Students' Perceptions Regarding Teaching and Learning Practices That Promote Safe Medication Administration

#### Nursing Education Perspectives 46(1):p 49-51, 1/2 2025

This article reports on a study conducted to explore what helps and what complicates learning safe medication administration. In this study, nurse educators explored students' perspectives on effective teaching practices, what influences medication errors and near misses, and strategies for improving students' learning about medication administration.

The challenges and needs of international nurses who are assimilating to healthcare systems in the United Kingdom: Experience from the field

#### Exploring person-centred practice

#### Nursing Standard, January 2025

Person-centred practice offers an approach to healthcare provision that prioritises the personhood of individuals. This means that nurses' ethical and professional values underpin their approaches to care, where each person and their rights, relationships and dignity are respected.

#### Homeostasis: understanding the effects of impaired mechanisms

This article focuses on homeostasis and offers a pathophysiological perspective. The dynamic mechanisms responsible for maintaining internal balance and disruptive processes will be analysed through the lens of key systems including the nervous, endocrine and renal systems.

#### How to assess a patient's chronic pain

Chronic pain is complex and multifactorial, and it can have a significant negative effect on all aspects of a person's daily life such as their physical activity, sleep, mood, ability to work and personal relationships. Given the complex nature of chronic pain, it is essential that nurses are able to undertake a comprehensive pain assessment to fully understand each individual's total pain experience.







### How to measure peak expiratory flow rate **Nursing Standard**, 9<sup>th</sup> **December 2024**

Measuring peak expiratory flow rate (PEFR) using a peak flow meter is a non-invasive, low-risk test that can be quickly taught to healthcare practitioners and/or patients, although using the correct technique is crucial for an accurate result.

How to take and record a manual blood pressure measurement
